The Safer Waitaki project is a 'wholeof-community' community development project with a focus on community safety and wellbeing. The project was initiated as a way to identify and respond to the key community priorities for the Waitaki District. It provides a mechanism for the community to work together, thus maximising resources and expertise. Waitaki has achieved accreditation and is recognised as a member of the World Health Organisation (WHO) International Safe Communities Network.

STRUCTURE OF SAFER WAITAKI

GOVERNANCE GROUP:

The Safer Waitaki Coalition is overseen by a Governance group comprised of 8 Governors from throughout the region representing Education, Local Government, Fire & Emergency, Police, ACC and Community.

MANAGEMENT GROUP:

- The role of the management group is to ensure strong communication and collaboration between the working groups to encourage and enhance activity.
- The group encompasses local, regional and national organisations. Membership includes government departments, local government, NGOs, Cultural Groups (e.g. Waitaki Multicultural Council, Waitaki Pasifika Network), Schools, and a wide range of community groups and organisations.
- The group meets monthly and there are often presentations on key issues such as housing, aging, issues affecting youth, education and employment.
- Agendas are sent out prior to each meeting and members can choose to attend anything that has relevance for their organisation.

WORKING GROUPS:

Through baseline research the Safer Waitaki Coalition identified and established working groups in key priority areas. These groups are: Waitaki Mental Health and Addictions; Positive Ageing Working Group; Alcohol and Drug Committee; Industry Link group (workplace employers group); Family Harm Provider Network; Family Whanau Group; Housing Taskforce.

The Safer Waitaki Network is coordinated by the Waitaki **District Council Community** Development Team. It is not a Trust or Incorporated Society. It is a coalition and works in a partnership model with Council. This structure provides a functional mechanism for advocacy, collective impact, research and development and also supports a myriad of functions that positively impact social and economic development. From a Council perspective the relationships, networks and engagement opportunities with Central Government, Government agencies, Non-Government Organisations and Community Groups, provides funding and community development opportunities otherwise not available to Council. It also acts as a conduit for Council community engagement where required.
